The Applicants declare that the information given above is true and complete and in making the application agree to abide by the following:

1. The Applicants hereby authorise the Bank to make such registry searches, valuations, and/or any other such enquiries related to the information provided in this form and to charge all costs of the enquiries to the Applicants' account with the Bank, whether or not the loan is agreed.
2. The Bank is hereby authorised to charge to the Applicants' account all costs of arranging and formalising the loan (registry searches, property valuations, taxes, notarial fees, agents' fees, Property Register fees, etc.) which will be chargeable to the Applicants who have been informed of this fact. The Bank is likewise authorised to charge the mortgage fees and repayments to the abovementioned account.
3. The Bank is authorised to carry out either directly or indirectly through auxiliary companies or professionals the necessary procedures for the verification of property or for the formalisation and registration of the mortgage.

4. The applicant is hereby informed that as provided in Law 44/2002, the Bank is legally obliged to declare to the CIR the necessary data to identify the natural and artificial persons with whom it has credit risks, as well as the characteristics of the said persons and risks, including those referring to the amount and recoverability of same. This obligation extends to the risks held via instrumental entities forming part of the consolidable groups of the Bank and those assigned to third parties under the Bank's administration. The data referred to in the preceding paragraph includes those which show any situation of a breach by the said persons of the obligations towards the Bank, as well as those which reveal a situation in which the Bank should be forced to form a specific provision in credit risk coverage, as provided in the accounting regulations to which the Bank is subject. In the event of risks of individual business persons engaged in the business activity, this will be recorded in the declaration. The applicant is also hereby informed that the Bank may obtain reports on the risks of same recorded in the CIR and that it may transfer to the other companies which form part of the consolidated group to which the Bank belongs. The information thus obtained will be confidential and may only be used in relation to the arrangement and management of credits and in order to ensure effective fulfillment of the regulation on risk concentration and any other which, as part of the precautionary supervision to which the Bank is subject, may be applicable.

5. The Applicants are hereby notified that the personal details required for the document to be properly drawn up and implemented, as well as those arising from the exercise of the stated operation will be added to the personal electronic data files of the Bank. The Applicants hereby consent to these personal details being used for the performance, the control and the management of the operation and likewise agree to such data being kept for the duration of time laid down under the applicable regulations.

The Applicants hereby expressly agree to:

- The processing of these personal details for the purposes of providing information related to the transactions of any other operation which the Bank considers advisable and especially as regards making offers and promotions and concluding agreements in connection with products or services and for the creation of profiles, analyses of new proposals and risk evaluations.
- The transfer of these personal details for the above mentioned purposes to other companies of the Banco Sabadell Group and subsidiary and auxiliary companies.

This should be done by notifying, in writing, those responsible for the files, namely the contracting Bank whose address is stated in the present document.

6. If for the purposes of the this application a life insurance is taken out with an Insurer which is part of the Banco Sabadell Group, the Applicants are informed that all the medical details provided when taking out the policy will be used by the Insurer only.

7. If, by means of the present application, a mortgage transfer to another Bank is requested and the mortgage is subsequently granted, the Applicants authorise the amount to be transferred to the Bank which granted the mortgage.

8. The Applicants are informed that, in accordance with the Law 36/3003, if the operation requested is a variable interest rate loan, the Applicants can take out an insurance to cover the risk of increased interest rates.
